

## Application for Historic (QQ) License Plates



### Brief Description and Eligibility

Historic registration may be assigned to an antique vehicle which is at least twenty-five (25) years old. The vehicle must be owned as a collector's item and used solely for exhibition or educational purposes. Please note that **the vehicle cannot be altered from the manufacturer's original design** in any way and must be equipped for legal operation on New Jersey roadways. Historic registration must be renewed every three (3) years, but there will be no fee for the renewal. The vehicle must be covered by the minimum automobile insurance coverage required by the State of New Jersey.

### Requirements

Please return your fully completed application with the following documents: 1) A photocopy of the current New Jersey title issued in your name. 2) Two color photographs of the vehicle, front and side view (may be printed on plain paper). 3) Pay required fee as follows: \$44 – Standard Historic Plates; \$74 – Courtesy Historic Plates; \$94 – Personalized Historic Plates (if you already own Standard Historic Plates, the personalized fee is \$50). **Please note: Historic motorcycle license plates are NOT available for personalization.**
