Reading and Approval of Minutes:



Executive Director's Report:

Mr. Vivas discussed with the Board the increase in transaction activity during the last two months and the current value of the Pinelands Credits, as they relate to current market conditions. He used the 13-month chart that follows—instead of a quarterly chart—to illustrate the trends:

Business of the Board:

Making reference to the Minutes from the October meeting, Commissioner Shinn discussed legal action taken in recent months in Burlington County regarding the enforcement of deed restrictions. Lengthy discussion ensued about how to establish participation between various agencies and groups that are all involved with land preservation as their common denominator. Ms. Ashmun felt that to start with, the efforts should be concentrated mostly between the Pinelands Commission and the PDC Bank, with participation of the DEP Green Acres; before bringing in such other entities like the Highlands Council and Burlington County.

Chairman Komjathy moved to establish a Committee on Administrative and Procedural Matters consisting of Susan Craft, Commissioner Bob Shinn, Fawn McGee (or an alternate designee) of the DEP Green Acres Program to represent the PDC Bank and work together with Acting Chairwoman Ashmun, Dan Kennedy and Ed McGlinchey of the Pinelands Commission. Ms. Ashmun volunteered to avail the Pinelands Commission's staff to coordinate the meetings at their office.

On a separate subject, Mr. Vivas informed the Board formally that he will be retiring from his position as of June 1, 2011. Chairman Komjathy communicated to the Board that the Department (DOBI) has a number of people retiring and they will be dealing with the situation.

Other Business: There was no public in attendance and there was no other business to discuss.

Adjournment: Chairman Komjathy adjourned the meeting at 11:05 a.m. on a motion by Mr. Auerbacher, seconded by Ms. Ashmun and a unanimous affirmative vote.
