BY THE BOARD:

By this Order, the New Jersey Board of Public Utilities ("Board") considers an Initial Decision executed by Administrative Law Judge ("ALJ") Tricia Caliguire and Stipulation of Settlement ("Stipulation") executed by New Jersey-American Water Company, Inc. ("Petitioner" or "Company"), the New Jersey Division of Rate Counsel ("Rate Counsel") and Board Staff ("Staff") (collectively, "Signatory Parties") intended to resolve the Company's requests related to the above docketed matter.

BACKGROUND/PROCEDURAL HISTORY

By Order dated April 2, 2007 in <u>I/M/O New Jersey American Water Company</u>, Elizabethtown <u>Water Company</u>, and <u>Mount Holly Water Company</u>, Docket No. WR06030257 (April 2, 2007), the Board required that all purchased water costs and purchased wastewater treatment costs be removed from base rates and recovered through the Purchase Water Adjustment Clause ("PWAC") and Purchase Wastewater (sewer) Treatment Adjustment Clause as applicable. On November 13, 2020, the Company a public utility of the State of New Jersey, filed a petition with the Board pursuant to N.J.S.A. 48:2-21 and N.J.A.C. 14:9-7.1 <u>et seq.</u> and other relevant statutes and regulations, for approval to change the levels of its existing purchased water adjustment clause ("PWAC") charge and purchased wastewater (sewerage) treatment adjustment clause ("PSTAC") charges, with respect to increased purchased water expenses and increased

purchased wastewater treatment expenses. The total amount requested in the petition would decrease annual revenues by (\$3,502,197) or -0.47% above total Company revenues of approximately \$807,900,000.

The petitioner services approximately 667,000 general metered water customers and approximately 46,000 sewer customers in all or part of 188 municipalities in 18 of the State's 21 counties.

The Company purchases water on a routine basis from six separate entities and purchases wastewater treatment services from three separate entities, each of which adjusts its rates for service, and, in the case of wastewater treatment service providers, issues sewerage deficit/credit adjustments, at different times throughout the year. The six water purveyors are: Passaic Valley Water Commission ("PVWC"); Morris County Municipal Utilities Authority; Montclair Water Bureau; New Jersey Water Supply Authority ("NJWSA"); City of Newark; and Marlboro Township Municipal Utilities Authority ("MTMUA"). The three wastewater treatment purveyors are: Cape May County Municipal Utilities Authority ("CMCMUA") for the Company's Ocean City Sewer tariff group; Ocean County Utilities Authority ("OCUA") for the Company's Lakewood Sewer tariff group; and Howell Township for the Company's Adelphia Sewer tariff group.

In the petition, the Company proposed to decrease its PWAC rate upon PWAC Rate Schedule O-1 from \$0.5113 per thousand gallons of water to \$0.4470 per thousand gallons of water for Non-Exempt customers. The Company proposed to decrease its PWAC rate from \$0.4425 per thousand gallons of water to \$0.3861 per thousand gallons for Exempt customers. It also proposed to address its PSTAC charges as follows:

For Lakewood Township, Ocean County, the rate per thousand gallons of prior year's winter quarter usage (January, February and March meter readings), as reflected upon PSTAC Rate Schedule 2-B, would change from \$4.6563 per thousand gallons to \$5.3156 per thousand gallons.

For customers in Ocean City, Cape May County, the rate per thousand gallons of prior year's summer water quarter usage (July, August and September meter readings), as reflected upon PSTAC Rate Schedule 1-B, would change from \$26.6334 per thousand gallons to \$29.3836 per thousand gallons.

For customers in the Adelphia section of Howell Township, Monmouth County, the rate per thousand gallons of water, as reflected upon PSTAC Rate Schedule 3-B, would change from \$7.1722 per thousand gallons to \$6.4940 per thousand gallons.

The Board transmitted this matter to the Office of Administrative Law ("OAL") for hearing as a contested case on January 11, 2021. A telephonic prehearing conference was held on March 22, 2021, with the ALJ Caliguire. On March 23, 2021, Middlesex Water Company ("Middlesex") filed a motion to intervene, which was not opposed by any party. On April 12, 2021 Mount Laurel Township MUA ("Mount Laurel") filed a motion to intervene, which was not opposed by any party. Middlesex and Mount Laurel were included on the service list, received all discovery, and invited to participate in all settlement conferences and meetings. Virtual public comment hearings were held via Zoom on April 27, 2021 at 4:30 p.m. and 5:30 p.m. Members of the public did not attend and no written comments were received.

STIPULATION¹

As a result of settlement discussions, the Signatory Parties agreed to the amount requested in this petition and executed the Stipulation June 3, 2021. Based upon and subject to the terms and conditions set forth in the Stipulation, the Signatory Parties stipulate and agree as follows:

The Signatory Parties recommend that the Board approve a change to the Company's PWAC rate on PWAC Rate Schedule O-1, reflecting a rate compression factor, from \$0.5113 per thousand gallons of water for Non-Exempt customers to \$0.4221 per thousand gallons of water for Non-Exempt customers and from \$0.4425 per thousand gallons of water for Exempt customers to \$0.3646 per thousand gallons of water for Exempt customers.

The Signatory Parties further recommend that the Board permit the Company to change its effective PSTAC charges, including the effects of the rate compression factor, as follows:

- For Lakewood Township, Ocean County², the rate per thousand gallons of prior year's winter quarter as reflected within PSTAC Rate Schedule 2-B from \$4.6563 per thousand gallons to \$4.9209 per thousand gallons.
- For customers in Ocean City, Cape May County³, the rate per thousand gallons of prior year's summer water quarter usage (July, August and September meter readings) as reflected upon PSTAC Rate Schedule 1-B, from \$26.6334 per thousand gallons to \$33.9147 per thousand gallons.
- For customers in the Adelphia section of Howell Township, Monmouth County, the rate per thousand gallons of water as reflected upon PSTAC Rate Schedule 3-B, from \$7.1722 per thousand gallons to \$6.6021 per thousand gallons.

The effective PWAC rate change, reflecting the effects of the rate compression factor, would result in a change in the annual bill of an average residential customer utilizing 5,400 gallons per month as follows:

The PSTAC rate changes, reflecting the effects of the rate compression factor, will result in: an increase for a typical residential sewer service customer in Lakewood Township, Ocean County utilizing 16,200 gallons of water in the winter quarter and 64,800 gallons of water annually, of \$1.43 per month or 2.33%; an increase for an average sewer service customer in Ocean City, Cape May County utilizing 17,000 gallons of water in the summer quarter and 31,000 gallons of water annually, of \$10.32 per month or 17.01%; and a decrease for an average sewer service customer in the Adelphia section of Howell Township, Monmouth County utilizing 64,800 gallons of water annually, of (\$3.08) per month or -4.23%.

These PWAC and PSTAC rates are calculated with an effective date of July 1, 2021.

NJAWC plans to file its next PWAC/PSTAC petition on or before November 15, 2021.

Within the Stipulation, the Signatory Parties have agreed on a methodology for calculating the amount of interest to be applied to over-recoveries within the PWAC. This method is described as follows: Total PWAC True-up Balance (Over)/Under-recovered of the current month (which is the adjusted total purchased water expense minus total PWAC revenues net of cost recoveries for the current month), plus the total PWAC Cumulative True-Up Balance (Over)/Under-recovery) of the prior month, minus the amortization of the PWAC True-Up from the previous PWAC year of the current month. The Signatory Parties agree to review this methodology and adjust it as necessary and appropriate in future PWAC proceedings.

The PWAC/PSTAC rates established herein will decrease annual revenues by (\$3,457,278) or -0.46%. Thus, the Company will collect annual revenues of \$36,160,285 for PWAC and \$18,409,362 for PSTAC.

On June 2, 2021, Middlesex Water and Mount Laurel filed letters indicating that they did not object to the settlement. On June 7 2021, ALJ Caliguire issued her Initial Decision/Settlement recommending adoption of the Stipulation executed by the Signatory Parties, finding that they had voluntarily agreed to the Stipulation and that the Stipulation fully disposes of all issues and is consistent with the law.

DISCUSSIONS AND FINDINGS

Having reviewed the record in this matter, including the Initial Decision and the Stipulation, the Board <u>HEREBY</u> <u>FINDS</u> that the Signatory Parties have voluntarily agreed to the Stipulation, and that the Stipulation fully disposes of all issues in this proceeding and is consistent with the law. The Board <u>FURTHER FINDS</u> the Initial Decision, which adopts the Stipulation, to be reasonable, in the public interest, and in accordance with the law. Therefore, the Board <u>HEREBY</u> <u>ADOPTS</u> the Initial Decision and the Stipulation, attached hereto, including all attachments and schedules, as its own, incorporating by reference the terms and conditions of the Stipulation, as if they were fully set forth at length herein, subject to the following:

In accordance with the provisions of N.J.A.C. 14:9-7.3(c) and 14:9-8.3(c), the Petitioner shall file with the Board, no later than 45 days after the adjustment clause has been in effect for one year, a PWAC true-up schedule in connection with this proceeding. Copies of the true-up schedule shall be served upon all parties to the present proceeding.

The Board <u>HEREBY</u> <u>DIRECTS</u> the Company to file tariff pages conforming to the terms and conditions of the Initial Decision, which adopts the Stipulation, and this Order within 10 days from the effective date of this Order.

The effective date of this Order is June 24, 2021 with rates to become effective on July 1, 2021.

BEFORE TRICIA M. CALIGUIRE, ALJ:

This proceeding involves the November 13, 2020, petition of New Jersey American Water Company (NJAW, Company) filed with the New Jersey Board of Public Utilities (Board) seeking approval of changes in the Company's purchased water adjustment clause and purchased wastewater adjustment clause. The petition was transmitted to the Office of Administrative Law (OAL) on January 11, 2021, for determination as a contested case. A telephone prehearing conference was held on March 22, 2021, and a prehearing order issued on March 31, 2021. After appropriate motions, and with no objections, Middlesex Water Company (Middlesex) and Mount Laurel Township Municipal Utilities Authority (MLTMUA) were granted intervenor status by orders dated March 31, 2021, and April 28, 2021, respectively.

On April 27, 2021, two duly-noticed¹ public hearings were conducted by the OAL using Zoom Video Communications, a remote video and audio platform, due to the COVID-19 public health emergency in which the Governor of the State of New Jersey has issued Emergency Orders mandating stay-at-home protocols for citizens and public employees and restricting public gatherings. No members of the public appeared at the virtual public hearings and no members of the public submitted written comments on the Company's petition. The comments made by petitioner, staff of the Board, and the representative of the Division of Rate Counsel were transcribed and made a part of the record.

On June 3, 2021, the parties filed a Stipulation of Settlement which resolves all issues in this proceeding. (J-1.) Said Stipulation of Settlement has been signed by petitioner, staff of the Board, and the New Jersey Division of Rate Counsel. Intervenors Middlesex and MLTMUA submitted letters of non-opposition to the Stipulation of Settlement.

The Stipulation of Settlement indicates the terms of settlement and is attached and fully incorporated herein.

¹ Proof of publication was provided by petitioner to the court reporter as an exhibit to the hearing transcripts; the public notice and proof of its publication are also part of the record.

I have reviewed the terms of settlement and I FIND:

- 1. The parties have voluntarily agreed to the settlement as evidenced by their signatures or their representatives' signatures on the attached document.

The total amount requested in the Petition would decrease annual revenues by (\$3,502,197) or -0.47% above total Company revenues of approximately \$807,900,000. New Jersey-American Water serves approximately 667,000 metered water and fire service customers and approximately 46,000 sewer service customers.

On April 2, 2007, the Board ordered that all purchased water costs and purchased wastewater treatment costs be removed from base rates and recovered through the PWAC and PSTAC as applicable. In the Matter of the Joint Petition of New Jersey American Water Company, Inc., Elizabethtown Water Company, and the Mount Holly Water Company for Approval of Increased Tariff Rates and Charges for Water and Sewer Services and other Tariff Revisions, BPU Docket No. WR06030257 (April 2, 2007). The Board last adjusted the Company's base rates effective November 1, 2020. In the Matter of New Jersey American Water Company for Approval

of Increased Tariff Rates and Charges for Water and Sewer Service and Other Tariff Modifications, Order Adopting Initial Decision/Stipulation, BPU Docket No. WR19121516 (October 28, 2020). The Company's base rates do not include PWAC or PSTAC pass-through charges to customers.

In the Petition, New Jersey-American Water proposed to decrease its PWAC rate upon PWAC Rate Schedule O-1 from \$0.5113 per thousand gallons of water to \$0.4470 per thousand gallons of water for Non-Exempt customers. Rate Counsel served interrogatories on New Jersey-American Water, which were responded to in full by the Company. During the proceeding, the Company received updated information from the various water and wastewater service purveyors whose costs comprise the Company's requested relief. This information was provided to all parties on a timely basis. The Company, Board Staff, Rate Counsel, and Middlesex participated in a discovery/settlement conference on May 27, 2021. As a result of the Company's Petition, discovery responses and negotiations, the Signatory Parties have reached a stipulation of settlement ("Stipulation"), the provisions of which are set forth below.

STIPULATION OF SETTLEMENT

1. The PWAC and PSTAC rates were originally calculated with an effective date of April 1, 2021, for the PWAC and PSTAC year ending March 31, 2022.

2. The effective date of the proposed PWAC and PSTAC rate changes is now anticipated to be July 1, 2021, and the Signatory Parties agree that a compression factor should be applied to the proposed rates to avoid a large disparity in the PWAC and PSTAC for the annual period ending March 31, 2022. In the event that the herein agreed to PWAC and PSTAC rates are implemented on a date later than July 1, 2021, these PWAC and PSTAC rates will be further compressed to take into account their effectiveness on this later date as the Signatory Parties acknowledge that the

rates shall be become effective upon the date set forth in the Board Order approving this Stipulation.

3. The Signatory Parties recommend that the Board approve a change to the Company's PWAC rate on PWAC Rate Schedule O-1, reflecting the rate compression factor described above in Paragraph 2, from \$0.5113 per thousand gallons of water for Non-Exempt customers to \$0.4221 per thousand gallons of water for Non-Exempt customers and from \$0.4425 per thousand gallons of water for Exempt customers to \$0.3646 per thousand gallons of water for Exempt customers.

4. The Signatory Parties further recommend that the Board permit the Company to change

its effective PSTAC charges, including the effects of the rate compression factor, as follows:

- For Lakewood Township, Ocean County¹, the rate per thousand gallons of prior year's winter quarter as reflected within PSTAC Rate Schedule 2-B from \$4.6563 per thousand gallons to \$4.9209 per thousand gallons.
- For customers in Ocean City, Cape May County², the rate per thousand gallons of prior year's summer water quarter usage (July, August and September meter readings) as reflected upon PSTAC Rate Schedule 1-B, from \$26.6334 per thousand gallons to \$33.9147 per thousand gallons.
- For customers in the Adelphia section of Howell Township, Monmouth County, the rate per thousand gallons of water as reflected upon PSTAC Rate Schedule 3-B, from \$7.1722 per thousand gallons to \$6.6021 per thousand gallons.
- 5. The effective PWAC rate change, reflecting the effects of the rate compression factor,

would result in a change in the annual bill of an average residential customer utilizing 5,400 gallons

per month as follows:

6. The PSTAC rate changes, reflecting the effects of the rate compression factor, will result in: an increase for a typical residential sewer service customer in Lakewood Township, Ocean County utilizing 16,200 gallons of water in the winter quarter and 64,800 gallons of water annually, of \$1.43 per month or 2.33%; an increase for an average sewer service customer in Ocean City, Cape May County utilizing 17,000 gallons of water in the summer quarter and 31,000 gallons of water annually, of \$10.32 per month or 17.01%; and a decrease for an average sewer service customer in the Adelphia section of Howell Township, Monmouth County utilizing 64,800 gallons of water annually, of (\$3.08) per month or -4.23%.

7. NJAWC plans to file its next PWAC/PSTAC petition on or before November 15, 2021.

8. Within this Stipulation, the Signatory Parties have agreed on a methodology for calculating the amount of interest to be applied to over-recoveries within the PWAC. This method is described as follows: Total PWAC True-up Balance (Over)/Under-recovered of the current month (which is the adjusted total purchased water expense minus total PWAC revenues net of cost recoveries for the current month), plus the total PWAC Cumulative True-Up Balance (Over)/Under-recovery) of the prior month, minus the amortization of the PWAC True-Up from the previous PWAC year of the current month. The Signatory Parties agree to review this methodology and adjust it as necessary and appropriate in future PWAC proceedings.

9. The PWAC/PSTAC rates established herein will decreases annual revenues by (\$3,457,278) or -0.46%. Thus, the Company will collect annual revenues of \$36,160,285 for PWAC and \$18,409,362 for PSTAC.

10. The Company will comply with the provisions of N.J.A.C. 14:9-7.4 regarding PWAC and PSTAC true-up schedules in connection with this proceeding. Copies of the true-up schedules will be served upon Board Staff and Rate Counsel.

11. This Stipulation shall be binding on the Signatory Parties to this proceeding upon approval hereof by the Board. This Stipulation shall bind the Signatory Parties in this matter only and shall not be considered precedential in any other proceeding involving the Signatory Parties hereto.

12. This Stipulation contains terms, each of which is interdependent with the others and essential in its own right to the signing of this Stipulation. Each term is vital to the agreement as a whole, since the Signatory Parties individually and jointly state that they would not have signed the Stipulation had any term been modified in any way. In the event that any modifications whatsoever are made to this Stipulation, each of the Signatory Parties hereto is entitled to certain procedures in the event of such occurrence.

13. If any modification is made to the terms of this Stipulation, the Signatory Parties must be given the right to be placed in the position in which each Signatory Party was before this Stipulation was executed. It is essential that each Signatory Party be given the option to modify its own position, to accept the proposed change(s), or to resume the proceeding as if no agreement had been reached.

14. The Signatory Parties believe that these procedures are fair to all concerned and, therefore, they are made an integral and essential element of this Stipulation.

15. This Stipulation may be executed in as many counterparts as there are signatories to this Stipulation, each of which counterpart shall be an original, but all of which shall constitute one and the same instrument.

16. The Signatory Parties understand that Middlesex and Mount Laurel will each file a letter with the OAL indicating that it does not object to the terms of the Stipulation.
