#### BY THE BOARD:

Administrative Law Judge Elia A. Pelios's Initial Decision in this matter was received by the New Jersey Board of Public Utilities ("Board") on May 18, 2022 ("ALJ Initial Decision"), therefore, the 45-day statutory period for review and the issuing of a Final Decision was to expire on July 5, 2022. On June 8, 2022, the Board issued an Order extending the deadline for the filing of exceptions to the ALJ Initial Decision to July 1, 2022, replies to exceptions to July 25, 2022, and the Board's time to issue a Final Decision 45 days to August 19, 2022. On August 17, 2022, the Board issued an Order extending the deadline to file exceptions to the ALJ Initial Decision to July 5, replies to exceptions to July 29, 2022, and the Board's time to issue a Final Decision 45 days to October 3, 2022. Prior to that date, and having received consent of all parties, Board Staff requests an additional 45-day extension of time for issuing the Final Decision in order to adequately review the record in this matter.

Considering the extended period of time for the filing of exceptions and replies, the voluminous record in this matter, and the consent of the parties, I <u>HEREBY FIND</u> good cause exists for an extension

of time pursuant to N.J.S.A. 52:14B-10(c) and N.J.A.C. 1:1-18.8, and, as such, I <u>HEREBY ORDER</u> that the time limit for the Board to render a Final Decision is extended until November 17, 2022.<sup>1</sup>
