ORDER OF EXTENSION

BPU DOCKET NO. EC22040301

BY THE BOARD:

Administrative Law Judge Jacob S. Gertsman's Initial Decision in this matter was received by the New Jersey Board of Public Utilities ("Board") on September 29, 2022. Therefore, the 45-day statutory period for the Board to review and issue a Final Decision was to expire on November 14, 2022. On November 9, 2022, the Board issued an Order extending the deadline to issue a Final Decision an additional 45 days to December 29, 2022.¹ On December 21, 2022, the Board issued an Order further extending the deadline to issue a Final Decision an additional 45 days to February 13, 2023.² Prior to that date, and having received consent of all parties, Staff now requests an additional 45-day extension of time for the Board to issue the Final Decision and in order to adequately review the record in this matter.




