BY THE BOARD:<sup>1</sup>

By this Order, the New Jersey Board of Public Utilities ("Board" or "BPU") considers the extension of the application submission deadline to 5:00 p.m. Eastern Time on August 4, 2023 for all qualified<sup>2</sup> bidders ("Applicants") to submit applications to the Board for consideration in the third offshore wind solicitation ("Third Solicitation").

**BACKGROUND**

In accordance with the Offshore Wind Economic Development Act ("OWEDA" or "Act"), Governor Murphy's Executive Order No. 8 ("EO 8"), Executive Order No. 92 ("EO 92") and Executive Order No. 307 ("EO 307"), on March 6, 2023, the Board opened the application window for the Third Solicitation for offshore wind projects in lease areas designated by the Bureau of Ocean Energy Management in federal waters on the outer continental shelf off the coast of New Jersey.<sup>3</sup> The Board also approved the use of the Solicitation Guidance Document ("SGD") to inform Applicants of the Third Solicitation process and the application requirements consistent with the rules at N.J.A.C. 14:8-6-1 et seq. Although non-binding, all prospective applicants were required to submit a notice of intent to respond ("NOI") by May 23, 2023.<sup>4</sup> As approved in the March 2023 Order, the Third Solicitation application submission deadline was June 23, 2023.

**DISCUSSION AND FINDINGS**

In order to allow applicants more time to develop their applications, the Board **HEREBY EXTENDS** the application submission deadline to 5:00 p.m. Eastern Time on August 4, 2023. N.J.S.A. 48:2-40. The SGD also set forth a Third Solicitation timeline.<sup>5</sup> With the extension of the application submission deadline, the Board **HEREBY AMMENDS** the Third Solicitation timeline as follows:
