**New Jersey Civil Service Commission Issued Law Enforcement Examination Entry Level List**

**TRENTON, NJ** - The New Jersey Civil Service Commission (CSC) issued the list for Entry Level Law Enforcement Examination (LEE) titles on November 8, 2023. The LEE assesses applicant readiness for entry into law enforcement titles including common knowledge, skills, abilities, and other characteristics.

This exam is offered annually by the CSC to all prospective police officers, correctional police officers, sheriff's officers, and other entry-level law enforcement titles. Interested applicants should anticipate a spring LEE announcement posting and a summer LEE exam. More information regarding dates and timelines will be released as they become available.

"The Civil Service Commission has been offering the law enforcement exam annually for the past two years," said Ryan Reinert, Director of CSC's Division of Test Development, Analytics, and Administration. "This frequent testing opportunity allows prospective candidates yearly opportunities to apply for careers in law enforcement and provides New Jersey municipalities with the flexibility to adapt to the challenges of filling these critical positions."
