



EAST POINT LIGHTHOUSE MAURICE RIVER TOWNSHIP, NEW JERSEY

Built in 1849, East Point Lighthouse is a relatively rare example of a lighthouse with an integrated keeper's dwelling and tower. By guiding vessels in and out of the Maurice River, now designated as one of the nation's wild and scenic rivers, the lighthouse was an important element in the maritime economy of the area. The lighthouse is the oldest in the Delaware River and Bay area, and the only operational lighthouse on the bay.

NJ Historic Trust and NJ DOT grants have helped fund 100% repointing of the exterior brickwork, reapplication of a protective exterior whitewash, the replacement of a standing seam metal roof and the reintroduction of the basement window openings. The grants also provided for the construction of an ADA accessible ramp to the first floor. Interior restoration activities have included plaster repair and repainting, re-glazing and repainting of the lantern and the installation of a sump pump to the basement. In order to better maintain interior moisture conditions (and increase comfort for visitors and docents) the project also included installation of a new HVAC system.

Long vacant, the lighthouse is now interpreted to the public by the Maurice River Historical Society. The historical society provides docent-led tours of the furnished lighthouse, holds special programing at the site, and participates in the Annual Lighthouse Challenge.

Sea level rise in the Delaware Bay has caused serious concerns regarding East Point Lighthouse's long-term survival. The U. S. Army Corps of Engineers is currently designing a project to lessen the severity of flooding events at the lighthouse. NJ DEP has installed temporary flood protections at the lighthouse until the larger project can be undertaken.

BOARD BIOS

Janet W. Foster, Morris County

An architectural historian and historic preservation consultant, Janet W. Foster is a proponent of New Jersey and its vernacular architecture. She teaches and writes on the topic, and is an adjunct faculty member in the Columbia University Historic Preservation Program. She serves on the Madison Borough Historic Preservation Commission, and on the Trustees of the Hartley Dodge Memorial. Ms. Foster was elected Chair in 2016 after serving two years as Vice Chair, and also serves on the Grants and Loans, Education and Outreach, and Legislation and Policy Committees.

Deborah Marquis Kelly, Burlington County

Ms. Kelly is a former executive director of Preservation New Jersey and since 1996 has been an independent historic preservation consultant through her company, Preservation Partners. She is the co-author of the New Jersey Women's Heritage Trail, the current secretary of the Chesterfield Township Historical Society, and chair of the newly-formed

Chesterfield Township Historic Preservation Commission. She is a past member and chair of the NJ Historic Sites Council and served on the Chesterfield Township Planning Board for 20 years. Ms. Kelly chaired the Trust from 2009-2011, continues to chair the Grants and Loans Committee, and serves on the Legislation and Policy and Strategic Planning Committees.

Peter Lindsay, PE, Sussex County

Mr. Lindsay has more than thirty years of professional experience in engineering and holds a Master's degree in Mechanical Engineering from New Jersey Institute of Technology. Presently employed in private industry, Mr. Lindsay is a life-long New Jersey resident. His former residence in Hardyston Township was one of the earliest homes built by the Joseph Sharpe family in 1809. Mr. Lindsay participated in the structural stabilization project of the Hamburg Presbyterian Church's 1868 sanctuary. His other interests include antique automobiles, history, and genealogy. He is a member of the Sons of Union Veterans of the Civil War and several classic car clubs in addition to professional organizations. Mr. Lindsay serves on the Acquisitions and Easements Committee.

Kenneth A. Miller, Morris County

Mr. Miller is retired from the financial services industry, and serves in a number of volunteer positions, including treasurer of the Joint Free Public Library of Morristown and Morris Township Foundation. He has been involved in preservation as a Commissioner and Chair of Morristown's Historic Preservation Commission, as well as restoring his private residence, a National Historic Landmark. He also serves Morristown as a Commissioner on the Vail Mansion Redevelopment Agency. Mr. Miller was elected Vice Chair in 2016, after serving for three years as Treasurer. He chairs the Acquisitions and Easements and Strategic Planning Committees.

Katherine Ng, LEED AP, Burlington County

Ms. Ng is the Vice President of Development for Wu & Associates, a general construction firm who has received widespread recognition for their restoration and preservation work from notable sources including the National Trust for Historic Preservation, state agencies, and local preservation organizations. Holding a Masters in Psychology from the University of California, Los Angeles, Ms. Ng's focus centers on the integration of culture into the fabric of sustainable community growth. She is an active proponent of historic preservation, having worked on the post-September 11th restoration of historic Chinatown in lower Manhattan; having served as a past Advisory Board Member for the Pennhurst Memorial and Preservation Alliance to develop an international site of conscience; and serving as an invited speaker for professional and collegiate preservation audiences. Ms. Ng was elected Secretary in 2016. She chairs the Legislation and Policy Committee and serves on the Strategic Planning Committee.

Meme Omogbai, MBA, CPA, CGMA, Somerset County

Named one of 25 Influential Black Women in Business by The Network Journal in 2010, Ms. Omogbai has been a leader in the nonprofit, corporate, museum and government sectors. As the first American of African descent named Board Chair of the American Alliance of Museums (AAM), Ms. Omogbai co-authored its ground-breaking strategic plan, The Spark, and led the initiative to rebrand the AAM as a global alliance. As Co-Director, Interim CEO, COO, CFO and Trustee, she led a major transformation in operating performance at the 105-year-old Newark Museum. Her program of financial accountability and innovation propelled the organization to the pinnacle of achievement with four consecutive years of 4-star ratings for superior management. Ms. Omogbai's background includes serving as the first minority and female Deputy Assistant Chancellor of New Jersey's Department of Higher Education. Her multifaceted earlier experience includes Big 4 Global Public Accounting, expertise in finance and management with the New Jersey Casino Control Commission and Barbizon Corporation. She currently serves as a Director on the the Advisory Board of Montclair State University's College of Science & Mathematics. She has also been appointed by the Emir of Borgu Kingdom to the Think Tank on the cultural infrastructure of the Emirate and establishment of its monuments and history museum. She is the Immediate Past Chair, after previously serving two years as Chair and two as Vice Chair.

Chris Perks, PE, Camden County

Mr. Perks is a licensed professional engineer, professional planner, and a certified municipal engineer. He is currently the Director of Engineering for the Philadelphia Parking Authority. His former consulting firm managed comprehensive renovations of the historic Philadelphia Academy of Music, the Philadelphia Water Works, and fifty-three Philadelphia Free Library buildings, fifteen of which were historic Carnegie buildings. Mr. Perks was the chairman of the Southern New Jersey Development Council and the Philadelphia Board of Building Standards. He also served on the New Jersey State Geographic Information Council, and the Camden City Historic Preservation Commission. He is currently on the boards of the Senator Walter Rand Institute of Public Affairs at Rutgers, Philadelphia Hospitality, the New Freedom Theatre, and he is the president of the Camden County Historical Society. Mr. Perks served as chairman of the New Jersey Historic Trust 2011-12, and as treasurer 2004-2005. He resides in the City of Camden.

Patricia Anne Salvatore, Cape May County

Ms. Salvatore founded, developed, and preserved/restored two history sites as nonprofit museums: Historic Cold Spring Village (where she currently serves as executive director) and Naval Air Station Wildwood Aviation Museum. She is a leader locally and regionally in promoting heritage tourism, having served on the board of the South Jersey Cultural Alliance since 1994 and the Cape May County Chamber of Commerce for nine years. Her contributions to historic preservation, interpretation and heritage tourism have been recognized by: the New Jersey Association of Museums John Cotton Dana Award, the Preservation New Jersey Sarah B. Fiske Award for Legacy & Leadership, the NJ State Federation of Women's Clubs and Douglass College of Rutgers University, the American Association for State & Local History, the Advocates for New Jersey Governor's Volunteer of the Year Award, the Smithsonian Magazine/Traveler's Conservation Foundation, and the NJ Governor's Conference. Ms. Salvatore chairs the Education and Outreach Committee.

YEAR IN REVIEW EDUCATION & OUTREACH

Throughout the year, the Historic Trust staff helps to plan and supports educational workshops and conferences that reach out to history and historic preservation audiences.

The Historic Trust continues to work with the NJ Historical Commission on the series of Best Practices Workshops for nonprofit history organizations. In 2017 the focus was on the financial health of a nonprofit organization, a two-part workshop.

The Trust's advisory relationship with Rutgers Camden and its Mid-Atlantic Regional Center for the Humanities continues as the university is now offering a full certificate program for historic preservation (see page 12).

The Trust co-sponsored two "Funders' Panels" in Cherry Hill and Morristown, to help introduce nonprofit organizations to grant-writing and potential sources of financial support from family funds, foundations, corporate and government funders.

The Historic Trust sponsored a Heritage Tourism workshop in Newark, led by a tourism consultant that works with communities and organization on developing interesting and engaging tours. The day included a walking tour, followed by lunch and an instructional workshop.



Trust Executive Director Dorothy Guzzo and Historic Preservation Specialist Glenn Ceponis participated on a panel at the annual APA-NJ conference in New Brunswick, where the topic focused on debunking myths of Historic Preservation. The Trust also had an exhibit table at the event.

YEAR IN REVIEW

HISTORIC PRESERVATION CONTINUING EDUCATION PROGRAM

The Historic Preservation Continuing Education Program at Rutgers University-Camden was launched in 2016 through a partnership between the New Jersey Historic Trust and the Mid-Atlantic Regional Center for the

Humanities (MARCH). Designed for those who desire to gain a deeper understanding of the vocabulary and discipline of historic preservation, students learn from professionals working in the field to gain a more realistic perspective on how the tangible remains of our past can be integrated

In 2017, the program began offering a Certificate in Historic Preservation. The certificate program is not a degree, but it can be used to supplement a student's work in an allied field, such as history or architecture. 

STRATEGIC PLAN

In response to a changing funding model, the Historic Trust updated its strategic plan to identify and prioritize new goals and initiatives for 2017-2020. The new plan outlines five major initiatives for the coming years:

- Increase funds available for historic preservation grants to at least \$10 million annually.
- Promote historic preservation as an effective tool for enhancing private redevelopment projects.
- Advance heritage tourism as an essential component of the state's tourism industry.
- Increase the Trust's role in advocating for and providing professional development to a wide range of people.
- Strengthen the NJHT's management and governance capacity, so that it will continue to thrive even when it faces external pressures.

GARDEN STATE HISTORIC PRESERVATION TRUST FUND COMPLETED PROJECTS

The New Jersey Historic Trust has awarded grants under the guidelines for the Garden State Historic Preservation Trust Fund since the Garden State Preservation Trust was established by a voter-approved ballet initiative in 1998, continuing the work of the previous bond-funded grant program. Bond referendums in 2007 and 2009 provided additional funds. Since 1990, more than \$137 million in matching grants have been awarded for 734 capital preservation and planning projects throughout the state.

Two categories of grants are awarded through the program. Historic Site Management Grants, up to \$50,000, help support planning exercises that promote effective management at historic sites. Capital Preservation Grants, up to \$750,000, help support construction expenses related to the preservation, restoration, and rehabilitation of historic properties and associated architectural and engineering expenses. In 2017, more than \$2.7 million was reimbursed for construction and planning activities. The following four capital and eleven planning projects were successfully completed and closed out.


CAPITAL PRESERVATION GRANTS

Metlar/Knapp/Bodine House, Piscataway, Middlesex County A \$150,000 matching grant to the township helped fund accessibility improvements for the house, one of two that remain from the Raritan Landing settlement and now houses collections and exhibits.

Church of the Redeemer, Morristown, Morris County A \$250,000 matching grant to the church helped fund the exterior restoration of the 1926 parish house, part of the church complex that hosts and sponsors many social and community programs.

A \$619,737 matching grant to the county helped fund the restoration of the Georgian style mansion, which hosted Washington's headquarters for two stints in 1780 and is a key component of the county's heritage tourism experience.

HISTORIC SITE MANAGEMENT GRANTS

Jacob's Chapel AME Church, Mount Laurel, Burlington County


A \$50,000 matching grant to the church helped fund the preparation of a National Register nomination and preservation plan for this church complex that includes a meeting house, chapel and cemetery associated with the African American Still family, early community leaders in South Jersey.

Perkins Center for the Arts, Moorestown, Burlington County

A \$34,500 matching grant helped fund the preparation of a preservation plan for the 1910 Tudor Colonial style

house that hosts an active arts education and presentation center.

St. Mary's Episcopal Church, Burlington County A \$50,000 matching grant to the church helped fund the preparation of a preservation plan for the 1846 Richard Upjohn designed church, which is a National Historic Landmark.



A \$50,000 matching grant to the borough helped fund an archaeological investigation, preparation of landscape plans, interpretive signage, lesson plans, and heritage tourism recommendations

Bivalve Shipping Sheds and Wharves,

Commercial Township, Cumberland County A \$46,125 matching grant to the Bayshore Center at Bivalve helped fund the preparation of interpretive materials and a marketing campaign for the facility, which interprets the early 20th century oyster industry.

John Lucas House,

Gibbsboro, Gloucester County A \$50,000 matching grant to the borough helped fund the preparation of a preservation plan and adaptive reuse plan to allow public use of this 1856 house, home to John Lucas an enterprising paint manufacturer.

A \$50,000 matching grant to the Barrow Mansion Development Corporation helped fund the preparation of a heritage tourism plan for the impressive Greek Revival style building that provides space for community organization offices, programs, meetings and exhibits.

A \$9,487 matching grant to the Wayne Historical Commission helped fund the preparation of construction drawings to replace the cedar roofs of the Van Riper Hopper House and Van Duyne House, both of Dutch Colonial construction.

"DISCOVER NJ HISTORY"

LICENSE PLATE FUND FOR HERITAGE TOURISM

The "Discover NJ History" License Plate Fund provides grants (up to \$5,000) to develop and promote visitor-ready sites as heritage tourism destinations. The Fund was established at the recommendation of the 2010 Heritage Tourism Master Plan for New Jersey. Since 2012, 29 projects have been awarded totaling \$117,273.68. The following grant awards were made in 2017:

Camden County Historical Society received \$5,000 to help fund a Partner Survey and Thematic Trail Identification, the first step in developing a Camden County Heritage Tourism Plan.

Montclair History Center received \$5,000 towards wayfinding and interpretive signage at its Orange Road campus that directs visitors both within the campus as well as to nearby historic sites.

South Mountain Theater Works & Television Productions received a \$5,000 grant award toward the cost

EASEMENT HIGHLIGHT

REHABILITATION OF CHURCH STREET SCHOOL

A historic school building in Long Branch, Monmouth County, will have a new life after decades of vacancy. Douglas Development of Washington, D.C. has begun the rehabilitation of the former school into twelve dwelling units.

The New Jersey Historic Trust accepted the donation of a perpetual easement on the Church Street School in 2015. The perpetual easement requires that the rehabilitation meet the Secretary of the Interior's Standards for Rehabilitation. The project architect, GTM Architects, is preserving the overall historic appearance of the building and incorporating the building's character defining features into the design. These features include the original windows, pressed metal ceilings, stairways, interior doors and some blackboards among other highlights.



Church Street School

The Long Branch School District constructed the Church Street School in 1891 to accommodate students in the North Long Branch section. The school was then named Primary School #3 and was the twin to the Broadway School, constructed the previous year and called Primary School #1. In 1900 an addition doubled the size of the school. In 1929 a fire destroyed the original hipped roofs and attic space, and were replaced with flat roofs. At this time, the school also constructed an auditorium to the rear of the building.

By 1986 the Church Street School was used only for storage. When it was listed on the National Register of Historic Places in 1999, The Historic Preservation Office noted that the resource represented the "best class of public school buildings that were being built in the generation following the Civil War," and it "exemplifies the type, period, and method of construction of this building type."

Thanks to a creative and experience developer, the school will continue to contribute to the historic character of its community.

ABOUT THE TRUST

The Mission of the New Jersey Historic Trust is to advance historic preservation in New Jersey for the benefit of future generations through education, stewardship and financial investment programs that save our heritage and strengthen our communities.

The Historic Trust seeks to achieve its mission by serving as:

- A leading voice for preservation at the state level.
- A catalyst for preservation and community revitalization activities.
- A full partner in state policy development.

The Trust also provides financial support, protection and technical assistance through its programs:

The Preserve New Jersey Historic Preservation Fund was established by legislation in 2016 to provide an annual source of matching grants from the state's corporate business tax for historic preservation projects. Eligible applicants include nonprofit organizations and government entities. The Preserve New Jersey fund continues the work of the Garden State Historic Preservation Trust Fund (2000-2012) and the Historic Preservation Bond Program (1990-1997). Since 1990, over \$150 million in matching grants has been awarded to worthy construction and planning historic preservation projects throughout the state.

In partnership with the 1772 Foundation, the Historic Trust offers matching Capital Preservation Grants up to \$15,000 to nonprofit organizations for exterior repair and restoration projects.

The Discover New Jersey Historic License Plate Fund for Heritage Tourism provides grants up to \$5,000 to develop and promote visitor-ready sites as heritage tourism destinations.

New Jersey Cultural Trust Capital Preservation Grants protect and improve historic properties that are used by nonprofit organizations that have history, humanities and arts programming. Grants may fund projects for stabilization, repair, restoration, adaptive use, and increased accessibility. Funding is offered on a schedule provided by the NJ Cultural Trust, which also qualifies eligible organizations.

The Historic Trust offers long-term, low-interest loans through the Historic Preservation Revolving Loan Fund for the acquisition, preservation, rehabilitation, or restoration of historic properties.

An Emergency Grant and Loan Fund has limited funds for critically needed work on endangered historic resources. Currently only loans are available.

The Preservation Easement Program ensures the preservation of privately-owned properties in perpetuity using deed restrictions. The Trust initiated the first statewide program of this kind, which enables easement donors to take advantage of charitable deduction tax benefits.

The Historic Trust accepts donations of real estate through New Jersey Legacies. Property donors may realize significant income and estate tax benefits by their donations. Donated properties are resold by the Trust with protective easements to ensure their preservation.
