


Ongoing Case Plans (n=1070) Compliance excludes children who exited in the last six months. 6 months average for Ongoing Case Plans is 97%.





[4] The data includes all 18-21 year olds who are active participants in an open CP&P case as of the end of the month.

Any of these youth may be receiving services. These definitions are currently being reviewed to better understand how we capture DCF's work with this population. The goal of this ongoing work is to create three meaningful categories for 18-21 year olds 1) Youth in a formal out-of-home placement setting, 2) Youth that achieved permanency, and 3) Youth that never achieved permanency.






Section VII: Tracking Data after SuperStorm Sandy 10 Most Impacted Counties









