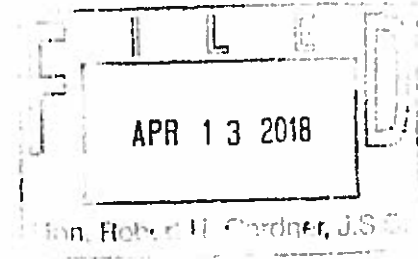

THIS MATTER having been opened to the court upon the motion of Plaintiff, Marlene Caride, the Acting Commissioner of the New Jersey Department of Banking and Insurance, for summary judgment in favor of Plaintiff and against Defendant, Yasmeen Scudder, and the court having read and considered the papers submitted, having heard oral argument, and for good cause shown:

IT IS on this 13<sup>th</sup> day of April 2018,

ORDERED as follows:

1. Summary judgment is hereby granted in favor of Plaintiff and against Defendant, Yasmeeen Scudder ("Defendant").

2. Defendant shall pay the sum of \$5,000.00 to Plaintiff as statutory penalties for multiple violations of the New Jersey Insurance Fraud Prevention Act, pursuant to N.J.S.A. 17:33A-5b.


3. Defendant shall also pay \$3,987.00 in attorney's fees to Plaintiff's counsel for all expenses incurred in litigation of this matter, pursuant to N.J.S.A. 17:33A-5b.

4. Defendant shall also pay a \$1,000.00 statutory insurance fraud surcharge, pursuant to N.J.S.A. 17:33A-5.1.

5. Defendant's driving privileges will be suspended for a period of one year from the date of this judgment, pursuant to N.J.S.A. 39:6A-15.

6. Judgment is entered in the amount of \$9,987.00 against Defendant and in favor of Plaintiff.

IT IS FURTHER ORDERED, that a copy of this Order be served upon all parties within 7 days of the date hereof.
