ORDER OF FINAL JUDGEMNT
BY DEFAULT

The Defendant, Leonard Evans ("Defendant"), having been duly served with a copy of the Summons and Complaint in the above-entitled action and default having been entered for failure to appear, answer or otherwise defend;

This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, specifically N.J.S.A. 17:33A-4(a)(1) and (4)(a)(3), by knowingly providing false and

misleading statements to Progressive Garden State Insurance Company ("Progressive") in support of an insurance claim.


FINAL JUDGMENT is on this _____ day of _____ 2020, entered in the amount of \$10,565.00 against Defendant Leonard Evans, and in favor of the Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of \$5,000.00 in civil penalties for two violations of the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30; attorneys' fees of \$4,500.00 pursuant to N.J.S.A. 17:33A-5; cost of service in the amount of \$65.00 pursuant to N.J.S.A. 17:33A-5; and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1; and

IT IS FURTHER ORDERED, that pursuant to N.J.S.A. 39:6A-15, Defendant's driving privileges shall be suspended for a period of one year from the date of this judgment.

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 7 days of the date of receipt.
