THIS MATTER HAVING BEEN opened to the Court on the application of Matthew J. Platkin, Acting Attorney General of New Jersey, (by Chandra M. FINAL JUDGMENT is on this 17th day of August 2022, as follows:

- 1. \$5,000.00 against Kenneth White, Sr., individually, for the Fraud Act violations alleged in Count 1 of the Complaint, pursuant to N.J.S.A. 17:33A-5(b);
- 2. \$5,000.00 against Kenneth White, Sr., individually, for the Fraud Act violations alleged in Count 2 of the Complaint, pursuant to N.J.S.A. 17:33A-5(b);
- 3. \$5,000.00 against Kenneth White, Jr. and Kenneth White, Sr., jointly and severally, for the Fraud Act violations alleged in Count 3 of the Complaint, pursuant to N.J.S.A. 17:33A-5(b);
- 4. \$5,000.00 against Kenneth White, Jr., individually, for the Fraud Act violations alleged in Count 4 of Complaint, pursuant to N.J.S.A. 17:33A-5(b);
- 5. A \$1,000 Fraud Act surcharge against Kenneth White, Jr., individually, pursuant to N.J.S.A. 17:33A-5.1;
- 6. A \$1,000 Fraud Act surcharge against Kenneth White, Sr., individually, pursuant to N.J.S.A. 17:33A-5.1;
- 7. Attorneys' fees in the amount of \$3,500.00 against Defendants, jointly and severally, pursuant to N.J.S.A. 17:33A-5(b);

- 8. Cost of service in the amount of \$80.00 against Kenneth White, Jr., individually, pursuant to N.J.S.A. 17:33A-5(b);
