**STIPULATION OF SETTLEMENT**

WHEREAS Plaintiff Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance ("Plaintiff"), and Defendant, Paul Kosmorsky, M.D., individually, in the matter of Commissioner v. Interstate Multi-Specialty Medical Group, et al. have reached an amicable agreement resolving the issues in controversy, and consented to the entry of the within Stipulation of Settlement ("Stipulation").

WHEREAS, the Parties have determined and hereby agree that settlement is in each of their best interests, and for good cause shown; and

WHEREAS, the Parties consent to the entry of the within Settlement pursuant to the terms and conditions below.

NOW THEREFORE, the Parties agree fully and finally to settle this matter pursuant to the terms and conditions below.

1. Defendant shall pay a to the Commissioner a Settlement Amount that consists of \$10,000.00 in civil penalties pursuant to N.J.S.A. 17:33A-5(b); \$500.00 in attorneys' fees pursuant to N.J.S.A. 17:33A-5(b) and \$500.00 in statutory surcharges pursuant to N.J.S.A. 17:33A-5.1.

2. This Stipulation represents a negotiated settlement and shall not be construed as an admission of liability or wrongdoing.

3. Defendant shall pay the Settlement Amount upon the following terms and conditions: Immediately upon execution of this

Stipulation by Defendant, but no later than July 1, 2023, Defendant shall remit to the attorney for the Commissioner a lump sum payment in the amount of \$11,000.00 by certified check, official bank check, or money order made payable to the "Commissioner, New Jersey Department of Banking and Insurance" and sent to:

4. No representation, inducement, promise, understanding, condition, or warranty not set forth in this Stipulation has been made to or relied upon by Defendant in agreeing to this Stipulation. Defendant represents that this Stipulation is freely and voluntarily entered into without any degree of duress or compulsion.

5. For purposes of construction, this Stipulation shall be deemed drafted by all Parties to this Stipulation and therefore shall not be construed against any Party for that reason in any subsequent dispute.

6. The undersigned counsel and any other signatories represent and warrant that they are fully authorized to execute this Stipulation on behalf of the persons indicated below.


8. This Stipulation may be executed in counterparts, each of which constitutes an original and all of which constitutes one and the same agreement.


