of the New Jersey Department of Banking and Insurance on a motion for final judgment by default; and

Defendant, Kyle Milev ("Defendant"), having been duly served with a copy of the Summons and Complaint in the above-captioned action and default having been entered for failure to appear, answer, or otherwise defend;

This Court now finds that Defendant violated the New Jersey Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"), by generating and presenting a false certificate of liability insurance to a general contractor with the purpose of creating the false and misleading impression that Geo Structural Corporation had commercial general liability coverage insurance when it did not, in violation of N.J.S.A. 17:33A-4(a)(6): and

FINAL JUDGMENT is on this **27TH** day of **FEBRUARY, 2024**;
entered in the amount of \$8,500.00 against Defendant Kyle Milev and in favor of Plaintiff, Marlene Caride, Commissioner of the New Jersey Department of Banking and Insurance. This amount consists of: a \$5,000.00 civil penalty for one violation of the Fraud Act, pursuant to N.J.S.A. 17:33A-5(b); attorneys' fees of \$2,500.00, pursuant to N.J.S.A. 17:33A-5(b); and a statutory fraud surcharge of \$1,000.00 pursuant to N.J.S.A. 17:33A-5.1; and

upon all parties within seven (7) days of the date of receipt.
