WHEREAS Plaintiff Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance ("Plaintiff" or "Commissioner"), and Defendant Pierre St. Phiryn ("Defendant") (collectively, the "Parties") have reached an amicable agreement resolving the issues in controversy, and consented to the entry of the within Stipulation of Settlement ("Stipulation").

WHEREAS the Parties have determined and hereby agree that settlement is in each of their best interests, and for good cause shown.

NOW THEREFORE, the Parties agree fully and finally to settle this matter pursuant to the terms and conditions below.

- Insurance Fraud Prevention Act, N.J.S.A. 17:33A-1 to -30 ("Fraud Act"). Specifically, Defendant: (i) made oral statements to an insurance company for the purpose of obtaining an automobile insurance policy falsely representing that he was the only driver of his insured vehicles when, in fact, his daughter was a driver of an insured vehicle, in violation of N.J.S.A. 17:33-A-4(a)(4)(b), and (ii) when applying for automobile insurance coverage for a vehicle, concealed and/or knowingly failed to disclose that his daughter was a driver of the insured vehicle, in violation of N.J.S.A. 17:33A-4(a)(3). Defendant further admits that he violated N.J.S.A. 17:33A-4(a)(1) as alleged in the Complaint.
- 2. Defendant's aforementioned conduct constitutes one violation of the Fraud Act, and any future violations of the Fraud Act shall be considered subsequent violations pursuant to 17:33A-5(c).

- 3. Defendant agrees that he shall not engage in any future violations of the Fraud Act.
- 4. Defendant shall pay a total judgment of \$4,150.00 to the Commissioner ("Settlement Amount"). This Settlement Amount consists of \$3,000.00 in civil penalties pursuant to N.J.S.A. 17:33A-5(b); \$1,000.00 in attorneys' fees pursuant to N.J.S.A. 17:33A-5(b); and a \$150.00 statutory surcharge pursuant to N.J.S.A. 17:33A-5.1.
- 5. Defendant shall satisfy the judgment upon the following terms and conditions:
- a. Immediately upon execution of this Stipulation by Defendant, Defendant shall remit to the attorney for the Commissioner a payment in the amount of \$250.00 by certified check, official bank check, or money order made payable to the "Acting Commissioner, New Jersey Department of Banking and Insurance" and sent to:

b. Defendant shall remit the remaining balance of 33,900.00 in thirty-five (35) monthly installment payments of 108.00 each, and a final thirty-sixth (36<sup>th</sup>) payment of 120.00,

to be paid on or by the first day of each month, beginning March 1, 2024, until the full Settlement Amount has been paid, by certified check, official bank check, or money order made payable to the "Acting Commissioner, New Jersey Department of Banking and Insurance" and sent to:

New Jersey Department of Banking & Insurance Attn: Collections Section P.O. Box 325 Trenton, NJ 08625

- 6. No representation, inducement, promise, understanding, condition, or warranty not set forth in this Stipulation has been made to or relied upon by Defendant in agreeing to this Stipulation. Defendant represents that this Stipulation is freely and voluntary entered into without any degree of duress or compulsion.
- 7. In conjunction with the execution of this Stipulation, the parties shall also enter into an Order of Entry of Judgment by Consent for the entire Settlement Amount, which will be docketed with the Superior Court of New Jersey as a statewide lien. A warrant of satisfaction shall be issued when the Settlement Amount is paid in full.
- 8. In the event of the failure by Defendant to pay any Settlement Amount installment payment when due, the entire Settlement Amount shall be immediately due and payable, upon

written notice by the Commissioner. Such notice shall be given to the person and address designated in Paragraph 12 by: (a) delivery in person; (b) a nationally recognized next-day courier service; or (c) first class regular or certified mail. Notice so given shall be effective upon: (a) receipt; or (b) on the fifth (5th) day following mailing, whichever occurs first. Defendant shall have an opportunity to pay the unpaid balance within fifteen (15) calendar days from the date of notice. If Defendant fails to pay the overdue unpaid balance of the payment obligations under this Stipulation within fifteen (15) calendar date of notice of non-payment, then days from the Commissioner may take any action available under the law of this State to collect the amount outstanding at that time, including post-judgment interest from the date of the judgment, attorneys' fees expended to date and to collect this debt, and any other remedies available under the law.

9. The Parties agree that each Party shall bear its own legal and other costs incurred in connection with this matter, and no additional attorneys' fees or costs shall be due, except Defendant agrees to pay Plaintiff's attorneys' fees pursuant to N.J.S.A. 17:33A-5(b) in the amount stated in Paragraph 4, plus all reasonable costs of collection and

enforcement of this Stipulation, including attorneys' fees and expenses.

- 10. For purposes of construction, this Stipulation shall be deemed drafted by all Parties to this Stipulation and therefore shall not be construed against any Party for that reason in any subsequent dispute.
- 11. The undersigned counsel and any other signatories represent and warrant that they are fully authorized to execute this Stipulation on behalf of the persons indicated below.
- 12. All communications from any party concerning the subject matter of this Stipulation shall be addressed as follows:

13. This Stipulation may be executed in counterparts, each of which constitutes an original and all of which constitutes one and the same agreement.

- 14. Pursuant to N.J.S.A. 17:33A-10(c), a copy of this Stipulation shall be provided to any appropriate licensing authority.
- 15. This Stipulation may be used in any subsequent civil or criminal proceedings.
- 16. The penalties included in this Stipulation are imposed pursuant to the police powers of the State of New Jersey for the enforcement of the law and protection of the public health, safety, and welfare, and are not intended to constitute debts which may be limited or discharged in a bankruptcy proceeding.
