SUBJECT: Approved Private Schools for Students with Disabilities Fundraising

It has come to the attention of the Department of Education that some approved private schools for students with disabilities (PSSDs) are requiring parents to participate in fundraising activities and/or requiring that each student/family raise a specified amount of funds in order for the student to continue his/her educational placement at the PSSD.

This practice is noncompliant with regulations, as delineated below:

The Department understands the need for voluntary fundraising among PSSDs; however, mandated fundraising either for placement or continued enrollment is not allowed. Any PSSDs currently engaging in non-allowed fundraising must immediately cease this practice.
