Take notice that the Office of Administrative Law (OAL) has discovered an error in the text of N.J.A.C. 10:66-6.2(q), promulgated by the Division of Medical Assistance and Health Services (Division) in the Department of Human Services. Effective December 21, 2009, the Division proposed and adopted new N.J.A.C. 10:66-6.2(q), which included a table of HCPCS codes (see 41 N.J.R. 2561(a); 4791(a)). As submitted to OAL for publication, the table contained three column headings (“Ind,” “HCPCS Code,” and “Maximum Fee Allowance”) and four columns. As published, the third column (which is clearly the HCPCS code) and the fourth column (which is clearly the maximum fee allowance) were both placed under the column heading “Maximum Fee Allowance” and the heading of “HCPCS Code” was placed over the double plus sign (§). As submitted, the “§” was not intended to have a column heading. That inadvertent error is being corrected herein.

Take notice that the Division of Medical Assistance and Health Services (Division) in the Department of Human Services has discovered an error at N.J.A.C. 10:77-2.5(d). Effective December 15, 2003, the Division proposed and adopted the recodification of N.J.A.C. 10:77-4 as 10:77-7. However, the Division inadvertently did not update the cross-reference to then-codified Subchapter 4 at N.J.A.C. 10:77-2.5(d)2 to refer to N.J.A.C. 10:77-7. This error is being corrected herein.

Upon receipt of the CMS 1500 claim form, the Medicaid/NJ FamilyCare fiscal agent will process the claim and reimburse the LHD the Federal share (50 percent for Medicaid and 65 percent for certain NJ FamilyCare-Plan A beneficiaries) of the amount approved by Medicaid/NJ FamilyCare (N.J.A.C. 10:77-[4]7), the remaining cost of this mandated service, as specified in N.J.A.C. 8:51, being the responsibility of the LHD.

Take notice that the Division of Family Development (Division) in the Department of Human Services has discovered an error in the text of N.J.A.C. 10:87-5.4(a)3ii. Effective March 16, 2009, the Division proposed and adopted new N.J.A.C. 10:87-5.9(a)10, thereby causing a recodification of existing paragraphs (see 40 N.J.R. 5932(a); 41 N.J.R. 1245(b)). As a result of the recodification of paragraph (a)10 as (a)11, the cross-reference at N.J.A.C. 10:87-5.4(a)3ii should have been updated, but inadvertently was not. That inadvertent error is being corrected herein.

SUBCHAPTER 5. FINANCIAL ELIGIBILITY; INCOME

10:87-5.4 Earned income

- (a) For the purposes of determining net NJ SNAP income, earned income shall include the following:
 - 1.-2. (No change.)
 - 3. The gross income from a self-employment enterprise, including the total gain from the sale of any capital goods or equipment related to the business (see N.J.A.C. 10:87-5.9(a)14).
 - i. (No change.)
 - ii. Payments received from a roomer or boarder shall be considered self-employment income, except income from foster care boarders, in accordance with N.J.A.C. 10:87-5.9[(a)10ii](a)11ii;
 - 4.-8. (No change.)
