RESOLUTION

**READoption OF STATE PLANNING RULES
AND APPROVAL FOR PUBLICATION IN THE NEW JERSEY REGISTER**

WHEREAS, the State Planning Commission has been created pursuant to the State Planning Act, N.J.S.A. 52:18A-196 et seq.; and

WHEREAS, N.J.S.A. 52:18A-203 of the State Planning Act authorizes the State Planning Commission to adopt rules and regulations to carry out its purposes including the preparation and adoption of a State Development and Redevelopment Plan; the undertaking of a cross-acceptance process in conjunction therewith; and the establishment of procedures to endorse municipal, county and regional plans that are consistent with the State Development and Redevelopment Plan; and

WHEREAS, pursuant to N.J.S.A. 52:18A-203, the State Planning Commission adopted the State Planning Rules as set forth in N.J.A.C. 5:85-1 et seq. relating to carrying out its purposes; and

WHEREAS, pursuant to N.J.S.A. 52:14B-5.1(b), the previously adopted State Planning Rules are scheduled to expire on August 21, 2015; and

WHEREAS, pursuant to N.J.S.A. 52:14B-5.1(c), the State Planning Rules may be readopted for an additional seven years, thereby extending the expiration date from August 21, 2015 to August 21, 2022, if the State Planning Commission files a notice of readoption of such rules in accordance with the requirements of the Administrative Procedures Act, N.J.S.A. 52:14B-1 et seq., prior to the expiration date; and

WHEREAS, the State Planning Commission has found the State Planning Rules remain necessary, reasonable, and proper for carrying out the purposes of the State Planning Commission;

NOW, THEREFORE, BE IT RESOLVED that the State Planning Commission, pursuant to its authority under N.J.S.A. 52:18A-203 of the State Planning Act, hereby approves a notice of readoption of the State Planning Rules and authorizes the publication of the notice in the New Jersey Register in accordance with the requirements of the Administrative Procedures Act, N.J.S.A. 52:14B-1 et seq.; and

BE IT FURTHER RESOLVED that the Chairman of the State Planning Commission and the Director of the Office for Planning Advocacy are hereby authorized to execute such documents and to take such other actions as may be necessary or appropriate for the publication of this rule proposal.
