STANDARD CONDITIONS:

- 1. Extent of approval: This document grants permission to perform certain activities that are regulated by the State of New Jersey. The approved work is described by the text of this permit and is further detailed by the approved drawings listed below. All work must conform to the requirements, conditions and limitations of this permit and all approved drawings. You must keep a copy of this permit and all approved drawings readily available for inspection at the work site. Approved work may be altered only with the prior written approval of the Department. If you alter the project without prior approval, or expand work beyond the description of this permit, you may be in violation of State law and may be subject to fines and penalties.
- 2. Acceptance of permit: If you begin any activity approved by this permit, you thereby accept this document in its entirety and agree to adhere to all terms and conditions. If you do not accept or agree with this document in its entirety, do not begin construction. You are entitled to request an appeal within a limited time as detailed on the attached Administrative Hearing Request Checklist and Tracking Form. You may also contact the project manager shown on the first page if you have any questions or concerns about this document.
- 3. **Recording with County Clerk:** You must record this permit in the Office of the County Clerk for each county involved in this project. You must also mail or fax a copy of the front page of this permit to the Department showing the received stamp from each County Clerk within 30 days of the issuance date (or 90 days if multiple counties are involved). The Department's address and fax number are shown on the first page of this permit.
- 4. **Notice of Construction:** You must notify the Department in writing at least 7 days before you begin any work approved by this permit. The Department's address and fax number are shown on the first page of this permit. Please direct your letter to the project manager shown on the first page.
- 5. **Expiration date:** All activities authorized by this permit must be completed by the expiration date shown on the first page. At that time, this permit will automatically become invalid and none of the approved work may begin or continue until a replacement permit is granted. (Some coastal permits may qualify for an extension of the expiration date. Please contact the Department for further information.)
- 6. **Rights of the State:** This permit is revocable and subject to modification by the State with due cause. The State may inspect the work site and may suspend construction if work does not comply with this permit. This permit does not grant property rights. The issuance of this permit shall not affect any action by the State on future applications, nor affect the title or ownership of property, nor make the State a party in any suit or question of ownership.
- 7. **Other responsibilities:** You must obtain all necessary local, Federal and other State approvals before you begin work. All work must be stabilized in accordance with the *Standards for Soil Erosion and Sediment Control in New Jersey*, and all fill material must be free of toxic pollutants in toxic amounts as defined in section 307 of the Federal Act.

SPECIAL CONDITIONS IN ADDITION TO THE STANDARD CONDITIONS:

- 8. All excavated material and dredged spoils must be disposed of in a lawful manner outside of any regulated flood plain, open water, freshwater wetlands or adjacent transition areas, and in such a way as to not interfere with the positive drainage of the receiving area.
- 9. Soil erosion controls will be installed prior to construction and maintained for the duration of the disturbance until soils have been stabilized. A soil erosion control plan approval must be obtained from the Soil Erosion Control District for the project.
- 10. Any discharge of dredged or fill material shall consist of clean, suitable material free from toxic pollutants (see 40 CFR 401) in toxic amounts, and shall comply with all applicable Department rules and specifications regarding use of dredged or fill materials.
- 11. This permit does not authorize the temporary use of any wetlands or transition areas beyond the limits of the proposed work other than specifically approved by this permit or as detailed by approved drawings. Such use of regulated areas applies to the storage or staging of construction materials (including debris/spoil piles), equipment, and workers' vehicles. The applicant shall direct the contractors to locate all staging and storage areas outside of wetlands and wetland buffers not approved for use by this permit.
- 12. In order to protect roosting Indiana bats (*Myotis sodalis*), tree clearing activities on the project site shall be prohibited from **April 1 to November 15** of each year. If clearing of trees cannot be avoided during this period, futher consultation will be required with the U.S. Fish and Wildlife Service.
- 13. In order to protect warmwater fishery resources within Rockaway River construction activities within the State open waters of this or any other stream on site are prohibited between May 1 thru June 30 of each year. In addition, any activity within the 100-year floodplain or flood hazard area draining to this watercourse which could introduce sediment into said stream(s) or which could cause an increase in the natural level of turbidity is also prohibited during this period. The Department reserves the right to suspend all regulated activities on site should it be determined that the applicant has not taken proper precautions to ensure continuous compliance with this condition.
- 14. The streambed shall be left intact and any in-stream disturbances must be restored using native streambed substrate.
- 15. The streambed is not to be disturbed between the cofferdams. Dewatering of cofferdams must ensure that the water quality of the Rockaway River is maintained by adhering to the following:
 - a) Turbidity barrier will be placed around all work areas, but the barrier will not restrict any stream channel by more than 50% of its cross-section. The turbidity barrier

should be placed parallel with the stream flow and anchored at the shorelines at points upstream and downstream of the work areas so that stream flows can be maintained at the channel center and outside the work areas.

- b) Turbid water from cofferdam and/or other excavation area dewatering will be routed to temporary sediment basins or filter membrane containers.
- c) The temporary filtering mechanisms will be sized appropriately to provide retention or filtration of water sufficient to ensure removal of suspended particulates prior to return discharge.
- d) The return water from the filtering facilities will be discharged to an area that is encompassed by turbidity barrier or silt fence to prevent migration of turbidity or soil erosion.
- e) The Permittee shall monitor for suspended sediments in nearby streams on a daily basis when any construction/demolition and dewatering is taking place. If sediment discharge is detected, then the project must cease until more appropriate preventative measures are put in place.
- f) The NJDEP reserves the right to suspend all work activities if turbidity levels of the stream are increased because of the regulated activities.
- 16. The proposed scour-hole for the stormwater outfall shall be placed into the banks to the maximum extent feasible in order to reduce intrusion into the streambed/banks
- 17. Any and all precautions are to be taken to prevent raw concrete, which is toxic to fish, from coming in contact with the waters of Rockaway River.
- 18. Implement landscape plan with native species to compensate for tree removal within 25 feet of top of the bank of the Rockaway River.
- 19. The permittee shall coordinate with the NJDEP's Site Remediation Program if project activities are determined to impact the contaminated properties of concern listed in the DOT's Division of Environmental Resources for the Hazardous Waste Screening Report regarding investigative and remedial requirements prior to the implementation of any construction activities within the project limits.
- 20. All dredged/excavated material temporarily stockpiled shall be analyzed for determination of waste classification and disposal option in accordance with applicable rules and regulations. Manifest of materials showing both characterization and disposition shall be submitted to the NJDEP.

21. Provisions of Freshwater Wetlands Statewide General Permit No. 10A

This Freshwater Wetlands General Permit 10A authorizes the disturbance of 0.003-acre (142 square feet) of State open water for the construction of a retaining wall along the northbound travel of South Salem Street. This permit also includes a wetland transition area waiver for disturbance of wetland transition area, which has been determined by the Department to be necessary to accomplish the authorized activities. Any additional disturbance of wetlands, transition areas and/or State open waters shall be considered a violation of the Freshwater Wetlands Protection Act unless the activity is exempt or a permit is obtained prior to the start of the disturbance from the Division of Land Use Regulation. In addition, this permit to conduct a regulated activity in a wetland or open water includes the Department's approval of a Water Quality Certificate for these activities.

22. Provisions of Freshwater Wetlands Statewide General Permit No. 11

This Freshwater Wetlands General Permit 11 authorizes the disturbance of 0.004-acre (160 square feet) of State open water for the placement of 3.04 cubic yards of rip-rap for sour protection at the base of a stormwater outfall. This permit also includes a wetland transition area waiver for disturbance of wetland transition area, which has been determined by the Department to be necessary to accomplish the authorized activities. Any additional disturbance of wetlands, transition areas and/or State open waters shall be considered a violation of the Freshwater Wetlands Protection Act unless the activity is exempt or a permit is obtained prior to the start of the disturbance from the Division of Land Use Regulation. In addition, this permit to conduct a regulated activity in a wetland or open water includes the Department's approval of a Water Quality Certificate for these activities.

- 23. Areas of temporary excavation must be restored with native, indigenous species. The stream bank must be restored with native vegetation and stabilized with the use of bioengineering materials, such as biologs, fiber matting, etc., except where riprap is required.
- 24. The stipulations of the Memorandum of Agreement (MOA) between the New Jersey Division, Federal Highway Administration and the New Jersey State Historic Preservation Office regarding replacement of the South Salem Street Bridge (Structure No. 1464-156) in the Town of Dover, Morris County, New Jersey shall be implemented.
- 25. The amount of rip-rap or other energy dissipating material placed shall be the minimum necessary to prevent erosion, and shall not exceed 3.04 cubic yards of fill, unless a larger amount is required in order to comply with the Standards for Soil Erosion and Sediment Control in New Jersey at N.J.A.C. 2:90.
- 26. Areas of temporary excavation must be restored with native, indigenous species. The stream bank must be restored with native vegetation and stabilized with the use of bioengineering materials, such as biologs, fiber matting, etc., except where riprap is

required.

- 27. The uppermost 18 inches of any excavation shall be backfilled with the original topsoil material.
- 28. The disturbed area shall be replanted with indigenous wetland plants.
- 29. Any excavation shall be backfilled to the preexisting elevation.
- 30. The permittee shall ensure the various regulated activities do not create pathways to drain the wetlands.
- 31. All pipes laid shall be properly sealed so as to prevent leaking or infiltration.
- 32. Any intake structure shall have an intake velocity no greater than 0.5 feet of water per second.
