Executive Summary

The purpose of this report is to provide an analysis of estimated savings attributable to changes made to the State Educators Health Benefit Plan (SEHBP) under Chapter 44 [P.L.2020, c.44 (C.52:14-17.46.14)] over the three-year period from January 1, 2020, to December 31, 2022, pursuant to Aon's interpretation of the law. This analysis is required under Chapter 44 to determine any further actions necessary by the SEHBP Plan Design Committee. Please refer to the Legislative Overview section of this report for further detail.

The results of this analysis are provided below. However, the reader should note that the available data provided for this analysis was limited, requiring numerous assumptions and projections in several areas to estimate savings. In addition, in some areas available data was not sufficient to produce any estimate of savings. The conclusions in this report include only the areas where estimated savings calculations were performed. Data limitations, assumptions made to resolve those limitations, and areas where calculations were not performed are described in detail in the Data Sources and Limitations section of this report and are essential to understanding the conclusions of this analysis.

Based on the methodology and assumptions contained in this report, the table below presents the estimated net savings resulting from the implementation of Chapter 44:

In the above table, "Gross Cost" refers to the cost of the Benefits Plan, after participant cost sharing has been adjudicated. "Contributions" refers to member contributions (employees or retirees), paid to participate in the Plan. "Net Cost" is Gross Cost less Contributions, that is the amount the plan sponsor(s) paid for the Benefits Plan.



Legislative Overview

P.L.2020, c.44 (C.52:14-17.46.14) ("Chapter 44"), approved on July 1, 2020, and amended on July 7, 2021, altered the benefits landscape of the School Employees' Health Benefits Program ("SEHBP") and for school districts which do not participate in the SEHBP. Chapter 44 impacted Actives and Retirees who are not yet eligible for Medicare ("Early Retirees") and included changes to plan designs offered through the SEHBP, two additional plans which must be offered by all school districts, and changes to participant contributions for individuals who enroll in certain plan design options. Chapter 44 does not impact Retirees who are eligible for Medicare ("Medicare Retirees"). This analysis reflects Aon's interpretation of the law as outlined below.

Plan Designs

Effective January 1, 2021, the SEHBP offers only the following four PPO plan designs for Actives and Early Retirees:

- SEHBP NJ DIRECT 10 ("DIRECT 10")
- SEHBP NJ DIRECT 15 ("DIRECT 15")
- New Jersey Educator's Health Plan ("NJEHP")
- Garden State Health Plan ("GSHP")

Chapter 44 prescribes the plan designs for two new plans, the NJEHP and GSHP. Active employees hired on or after the effective date of Chapter 44 (assumed to be July 1, 2020) are required to enroll in either the NJEHP or GSHP from January 1, 2021, through December 31, 2027. All Early Retirees are required to enroll in the NJEHP or GSHP from January 1, 2021, through December 31, 2027. Beginning January 1, 2028, all participants at SEHBP and non-SEHBP employers may enroll in any available plan design. Components of the plan designs offered by the SEHBP are summarized in the Appendix.

All other Active and Early Retiree plan designs which were available in the SEHBP prior to January 1, 2021, were eliminated as a result of Chapter 44. School districts which do not participate in the SEHBP are permitted to continue offering plan designs offered prior to January 1, 2021, but must also offer the NJEHP and GSHP and, with limited exceptions, may not offer any new health care benefit plans until January 1, 2028. No changes may be made to the plan designs offered to eligible participants in either the SEHBP or outside the SEHBP until January 1, 2028, except to satisfy the savings requirement described in the legislation; or if collective bargaining agreements were negotiated prior to the effective date of Chapter 44 and result in additional premium cost reductions. Any plan design changes made to achieve the Chapter 44 savings requirement must be effective January 1, 2024.



Chapter 44 amended all plan designs offered by the SEHBP to reflect out-of-network reimbursements for physical therapy, chiropractor and acupuncture services equivalent to reimbursements provided under the State Health Benefits Program ("SHBP") effective beginning August 1, 2020. This requirement does not impact health plans operated by non-SEHBP employers.

Participant Contributions

Chapter 44 prescribes the participant contributions for the NJEHP and GSHP. Participant contributions for plan designs offered by the SEHBP are summarized in the Appendix.

Participants who enroll in either the NJEHP or GSHP are eligible to contribute a percentage of their salary (retirement allowance if retired, including any cost-of-living increases) or a percentage of premium as determined under Chapter 78, P.L. 2011 ("Chapter 78"), whichever is less. Chapter 44 makes no changes to participant contributions for participants enrolling in the DIRECT 10 or DIRECT 15 plan designs offered through the SEHBP. Participants enrolling in the GSHP pay contributions equal to half of the contributions required for the NJEHP, subject to a minimum contribution of 1.5% of salary (retirement allowance if retired, including any cost-of-living increases) as required by law.

There exist certain SEHBP participants who were not required to contribute towards the cost of their health care coverage prior to the adoption of Chapter 44. Similarly, some non-SEHBP employers may have engaged in collective bargaining with their employees that may include provisions for participant contributions different than what is required under Chapter 78. Chapter 44 does not create a new contribution requirement for individuals who are not otherwise required to pay participant contributions prior to the adoption of Chapter 44. Participants who currently pay the full cost of coverage are required to continue contributing the full cost of coverage regardless of their plan election.

From January 1, 2021, through December 31, 2027, SEHBP and non-SEHBP employers may not make any changes to the participant contributions for the NJEHP and GSHP unless in order to satisfy the Chapter 44 savings requirement. Any participant contribution changes made to achieve the Chapter 44 savings requirement must be effective January 1, 2024.

Chapter 44 Savings Requirement

To avoid changes to the plan designs or participant contributions described by Chapter 44, the legislation requires at least \$300 million of cumulative net savings by comparing Plan Years 2020, 2021 and 2022 (January 1, 2020, through December 31, 2022) for all school districts and county colleges both that do participate and do not participate in the SEHBP, including Early Retirees. School districts which realize savings as a result of the implementation of Chapter 44 are required to use those cost savings to directly reduce the amount that is required to be raised by local property taxes, with some exceptions.

Per Chapter 44, the savings is determined by measuring the implementation of the NJEHP and GSHP; changes made to the DIRECT 10 and DIRECT 15 plans offered through the SEHBP; and also includes the value of early plan design changes implemented in Fiscal Year 2020 (July 1, 2019, through June 30, 2020). Per Chapter 44, no monies from the claims stabilization reserve ("CSR") fund or equivalent fund established or maintained for the SEHBP to pay incurred claims that have not yet been settled shall be



used for calculations of the Chapter 44 savings requirement. Any employers who have collective bargaining agreements in place which provide for greater savings than would be achieved by adopting the NJEHP or GSHP into their programs are expected to engage in collective negotiations to address the financial impact of the difference, which is not addressed in this analysis.

In the event savings resulting from the implementation of Chapter 44 are less than \$300 million, plan design and / or participant contribution changes may be made in order to achieve \$300 million in cumulative net savings by December 31, 2027. Chapter 44 does not specify any required action if the savings target is achieved initially but is subsequently eroded.

To support the determination of the Chapter 44 savings, school districts are required to submit the following data to the Department of Education, the Division of Pensions and Benefits, and the Legislature; separately by coverage category (Single, Employee + Spouse, Parent + Child(ren), Family):

- Total Annual Cost of Health Benefits for Active Employees
- Total Employee Cost-Sharing Contribution
- Net Cost to the School District for Health Benefits
- Number of Covered Employees
- Annual Cost Estimate Per Employee



Methodology

For purposes of this analysis, the estimated financial impact is calculated by comparing actual premiums/costs and participant contributions with a baseline cost estimate actuarially adjusted to exclude benefit and participant contribution change impacts. Baseline gross cost estimates are calculated using actual premiums and enrollment projections for Actives and separately using actual costs for Early Retirees. This analysis does not include any potential financial impact related to financial accounting liabilities or expenses which may arise due to the implementation of Chapter 44.

The determination of the Chapter 44 financial impact includes Active and Early Retirees of public school districts and county colleges in New Jersey. Private schools and charter schools which operate in New Jersey are excluded from consideration in this analysis. Medicare Retirees are also excluded from consideration in this analysis.

Plan Changes

This analysis reflects the following:

- Resolution of the School Employees' Health Benefits Plan Design Committee ("SEHBP PDC")
 creating a new plan "New Jersey Educators Health Plan" and terminating all plans other than
 SEHBP NJ DIRECT 10, SEHBP NJ DIRECT 15, and the New Jersey Educators Health Plan (NJEHP) for
 Employees and Retirees that are not Medicare eligible. Gross cost savings in the new plans was
 estimated using Aon's Actuarial Value model and also included a medical savings estimate provided
 by Horizon for OON reimbursement changes and a prescription drug savings estimate provided by
 Optum for mandatory generic, formulary, and corresponding rebate changes.
- Resolution 2020-02 of the SEHBP PDC limiting out of network coverage for certain services. This resolution changed reimbursement for out of network physical therapy, chiropractic, and acupuncture services effective August 1, 2020. This change affects Actives and Early Retirees. Estimated annual medical savings of 7% for Actives and 5.4% for Early Retirees were provided by Horizon.
- Additional financial impacts resulting from administrative changes in the reimbursement policy of the SEHBP affecting out-of-network costs in 2020. Effective March 1, 2020, Out-of-Network medical claims for plans that reimburse based on FAIR Health database are reimbursed based on the National Database of associated charges, rather than based on charges grouped by three-digit zip code. This reimbursement methodology is estimated to reduce projected Local Education Active and Early Retiree PPO medical claims by 5.1% and 3.8% annually, respectively.

Participant Contribution Changes

Prior to Chapter 44, participant contributions were determined as a percent of premium under Chapter 78. Participants who enroll in the NJEHP created by Chapter 44 are eligible to contribute a percentage of their salary (retirement allowance if retired, including any cost-of-living increases) or a percentage of premium as determined under Chapter 78, whichever is less. Chapter 44 makes no changes to



participant contributions for participants enrolling in the DIRECT 10 or DIRECT 15 plan designs offered through the SEHBP. Participants enrolling in the GSHP pay contributions equal to half of the contributions required for the NJEHP, subject to a minimum contribution of 1.5% of salary (retirement allowance if retired, including any cost-of-living increases) as required by law. Additional costs due to contributions which were lowered under Chapter 44 are included in this analysis as a reduction to estimated savings, except as outlined in the Data Sources and Limitations section of this report. A detailed description of the contributions under Chapter 44 are provided in the Appendix section of this report.

Other Considerations

There were shifts in enrollment between available plan options due to the implementation of Chapter 44. To account for how these shifts have influenced potential savings, baseline cost estimates are adjusted to reflect enrollment for each period in plan designs which were available prior to the implementation of Chapter 44 for both Actives and Early Retirees, based on historical enrollment.

A premium holiday was extended to SEHBP participating employers for active employees for the month of January 2022 in recognition of balances in the claims stabilization reserve ("CSR") which exceeded targets. Per Chapter 44, no monies from the CSR maintained for SEHBP Actives or other funds used to pay incurred claims are included in the calculation of the Chapter 44 financial impact. Actual costs and estimated baseline costs have been adjusted to remove any impact of the contribution holiday from the calculation of the Chapter 44 impact. Aon is not aware of other funds used to pay incurred claims and no other adjustments are reflected in the financial impacts resulting from the implementation of Chapter 44.

Active Methodology

The State of New Jersey provides coverage through the SEHBP to active employees of school districts and other Local Education employers who elect to participate. The SEHBP allows these employers to purchase medical and/or prescription drug coverage on behalf of their employees for premium rates which are set in advance of each plan year. Alternatively, employers who are eligible to enroll in the SEHBP have the option to obtain health insurance coverage on behalf of their employees outside the SEHBP, either through obtaining fully-insured coverage from an insurance provider or through self-insuring the costs of their own benefits program. This analysis includes both employers that participate in the SEHBP and eligible employers that chose not to participate in the SEHBP during the covered time period.

Chapter 44 requires that the estimated financial impact includes county colleges which cover Active employees in the State of New Jersey. Actual and baseline county college costs and participant contributions are estimated based on census data, plan elections, participant contributions and premium costs provided to Aon by the Division of Pensions and Benefits from January 1, 2020, through December 31, 2022.

The estimated Chapter 44 financial impact attributable to Actives is equal to the difference between actual costs / premiums (including projected actual costs) and estimated baseline costs, both net of participant contributions.



Early Retiree Methodology

The State of New Jersey provides coverage to eligible Early Retirees of school districts and other Local Education employers and enrolls these individuals and their covered dependents in the SEHBP, which pays medical and prescription drug claims as they are incurred as well as other costs incurred to administer health care benefits provided through the SEHBP. Actual and estimated baseline costs attributed to Early Retirees are based on aggregated and actuarially adjusted medical and prescription drug costs incurred from January 1, 2020, through December 31, 2022, inclusive of other costs and credits paid and received by the SEHBP.

Early Retiree medical and prescription drug costs include the following components for Plan Years 2020, 2021 and 2022 (January 1, 2020, through December 31, 2022):

- Medical and prescription drug claims incurred through December 31, 2022, with run-out through March 31, 2023.
- Payments made to capitated providers.
- Prescription drug rebates received by the SEHBP for prescription drugs administered through both the medical and prescription drug plans.
- SEHBP surcharge offset, which functions as a credit funded by non-participating Active employers to reduce gross premium rates for SEHBP Early Retirees.
- Administrative fees paid by the SEHBP.
- Investment income and overhead charges.

As of January 1, 2020, Early Retirees had the option to enroll in one of nine medical and prescription drug plan designs offered by the SEHBP. Effective January 1, 2021, Early Retirees were permitted to enroll in the newly introduced NJEHP. Effective July 1, 2022, they could choose between the NJEHP and the GSHP. Actual costs for this analysis reflect actual plan enrollments during this period. Baseline cost estimates for Plan Years 2021 and 2022 are adjusted to presume enrollment in plans offered by the SEHBP prior to the adoption of Chapter 44, based on historical enrollment in available plan options.

Any potential financial impact associated with changes in Early Retiree participant contributions due to Chapter 44 is excluded from this analysis due to limitations as described in the Data Sources and Limitations section of this report.

The estimated Chapter 44 financial impact attributable to Early Retirees is equal to the difference between actual gross costs and estimated baseline gross costs.



Data Sources and Limitations

Active Employees

Active employees may be in the Plan administered by the State, or a variety of other plans run by other administrators. While the Department of Education (DOE) collects actual health care costs and participant contributions for active employees of each school district, by coverage tier and by plan, gaps in that data prevented an adequate comparison for the entire study period. Additional details are described below.

Aon received data from the following sources for the active employee analysis:

- Monthly enrollment files for SEHBP participating employers; provided by the State.
- Working premium rates (gross plan cost) by year, by plan, and by enrollment tier; as listed in the
 publicly available annual Rate Setting Analysis documents.
- As of the date of this report, the DOE data has been provided for the period January 1, 2020, through June 30, 2022, and projected data has been provided for the period July 1, 2022, through June 30, 2023. This data includes information for both SEHBP-participating and non-participating employers.
 - Not all known employers were included in the DOE data and specific employers included in each year varied.
 - In addition, some other aspects of the data in these files were adjusted where deemed unreasonable, as specified below.
 - Please see the Appendix for a list of employers included in DOE data files in each year.
- County college cost data, by coverage tier and by plan, for the period January 1, 2020, through December 31, 2022: provided by the State.

Limitations on the available data influenced the calculation methods used in this analysis as discussed below:

SEHBP-participating Employers: Monthly enrollment files and working premium rates were used to determine calculated costs for SEHBP-participating employers.

If these employers also appeared on the DOE file and employee contribution information was included, then a total employee cost sharing percentage was calculated for that employer as the ratio of employee contributions to total costs as reported on that file. This percentage was calculated separately for non-SEHBP plans, SEHBP plans that are not NJEHP/GSHP, and for NJEHP/GSHP. To estimate baseline contributions, these percentages were applied to estimated baseline costs for non-SEHBP plans and SEHBP plans that are not NJEHP/GSHP. For NJEHP/GSHP, the average contribution percentage under the baseline non-NJEHP/GSHP groups is applied to the estimated baseline cost for the NJEHP/GSHP. If SEHBP-participating employers were included in one year of the DOE data but not in later years, then the estimated employee cost sharing percentage was carried forward to future years



where DOE data was missing. If SEHBP-participating employers were not included in any year of the DOE data, then any potential Chapter 44 impact on employee contributions was excluded from the analysis. No contribution data was provided for any county colleges and no contribution-related additional costs or savings were estimated for these employers. Please note that contribution changes under Chapter 44 generally reduced cost for employees and increased plan costs; as such where contribution data is not available and contribution impacts have been excluded from the analysis, overall savings estimates may be overstated.

For employers participating in the SEHBP for medical benefits only, no Chapter 44 savings was estimated attributable to carved out Rx benefits.

Non-participating Employers: If non-participating employers appeared on the DOE data, that data was used to estimate calculated gross costs and employee contributions. Savings were estimated for only the years in which each employer appeared in the DOE data. Many individual employers were not included in the DOE data for one or more years, especially for Plan Year 2021, and no savings were estimated for years in which non-participating employers did not appear in the data. Please note that actual plan changes under Chapter 44 for non-SEHBP participating employers for which no data is available may have in fact resulted in overall savings; as such where gross cost data is not available and impacts have been excluded from the analysis, overall savings estimates may be understated. Where the plan name data field for non-participating employers did not match the plan type field (type O = pre-Chapter 44 plan, type A = post-Chapter 44 PPO10/15, type B = NJEHP/GSHP), the plan name field was assumed to be accurate.

Early Retirees

Sourcing data on early retirees is significantly less challenging, as all retirees are in the State run plan. Cost data from that plan was available for the entirety of the study period. Aon was not provided with a reasonable source of data on actual contributions paid by early retirees and any consideration of a potential Chapter 44 impact on early retiree contributions is excluded from this analysis.

Aon received data from the following sources for the early retiree analysis:

- Monthly enrollment files were received from the State for all early retirees.
- · Actual claims and administrative cost data were provided by Horizon and Optum
- Additional cost data provided by the State.

Monthly enrollment files and actual cost data were used to determine actual costs for early retirees.

Prescription drug plan design components and Actuarial Values for the DIRECT 10 and DIRECT 15 plans are shown for the prescription drug copay plan option.

Deductibles, coinsurances and out-of-pocket maximums are provided for single and family coverages.

In-network coinsurance payments are required only on select services.

Consistent with the SHBP: out-of-network chiropractor reimbursements are equal to the lesser of \$35 per visit or 75% of the in-network cost per visit; out-of-network acupuncture reimbursements are equal to the lesser of \$60 per visit or 75% of the in-network cost per visit; and out-of-network physical therapy reimbursements are equal to 75% of the in-network cost per visit.

For participants who enroll in either the NJEHP or GSHP: under a patient centered medical home model, there is no office visit copay for primary care for participants who select and commit to a patient centered medical home for primary care in accordance with plan rules and regulations.

As of January 1, 2021, all Early Retirees are required to enroll in the NJEHP until January 1, 2028.

Deductibles, coinsurances, and out-of-pocket maximums are provided for single and family coverages.

In-network coinsurance payments are required only on select services.

Consistent with the SHBP: out-of-network chiropractor reimbursements are equal to the lesser of \$35 per visit or 75% of the in-network cost per visit; out-of-network acupuncture reimbursements are equal to the lesser of \$60 per visit or 75% of the in-network cost per visit; and out-of-network physical therapy reimbursements are equal to 75% of the in-network cost per visit.

For participants who enroll in either the NJEHP or GSHP: under a patient centered medical home model, there is no office visit copay for primary care for participants who select and commit to a patient centered medical home for primary care in accordance with plan rules and regulations.



Chapter 44 Participant Contributions

Participants who enroll in either the NJEHP or GSHP are eligible to contribute a percentage of their salary (retirement allowance if retired, including any cost-of-living increases) or a percentage of premium as determined under Chapter 78, whichever is less. Chapter 44 makes no changes to participant contributions for participants enrolling in the DIRECT 10 or DIRECT 15 plan designs offered through the SEHBP.
